1 Scope

This document includes the price list of WiMAP-4G. It replaces all previous price lists.

2 Prices and license terms

2.1 License terms

2.1.1 Editions: Community and Professional

The Professional Edition offers the complete feature set, apart from services that need to be licensed against third parties.

The Community Edition has additional project orientated limitations. In one project the number of possible sites is restricted. Also the resolution for displaying the calculation results is limited and parts of the import/export functions are inaccessible. We reserve us the right to restrict new and more functionalities in future releases of WiMAP-4G Community Edition.

2.1.2 License and Support

The support agreement includes free e-mail support and free updates for WiMAP-4G during the license period.

Telephone support can be booked additionally to a support agreement and will be charged on a 15 min basis.

During the license period updates for WiMAP-4G Professional Edition will be free of charge, for the Community Edition this can, but explicitly does not have to apply.

Trainings and/or on-site support are not included in any license, but are available and can be purchased on request.

2.1.3 Warranty

Correctness and completeness of the data of third parties used in this software is not warranted. The SRTM elevation data, building data, satellite images or OpenStreetMap materials are belonging to this third party data. It is also outside the responsibility of this license to warrant the access to the data of the according providers.

Correctness and completeness of the building up results is not part of any warranty either.

Besides these special conditions the General Terms of brown-iposs apply.

2.2.3 CORLA (3D Prediction)

Licenses for CORLA are provisioned on project basis. They are not restricted to any specific hardware, neither to a specific user. The term project is based on the size of the area of interest. The covered area of one project is 1,000 km² and it is limited to 20 Sites (locations of base station or access points). The excess of these numbers results into an additional project (up to 2,000 km² and up to 40 Sites is counted as 2 projects, and so on).
